SHAC will provide a dedicated website page with artist listings; social media postings, postcard mailing (plus postcards given directly to the artists), press releases, event notice on City of Shaker Heights' website, email-announcements and more. SHAC will provide table sitters for brief artist breaks.

Rules for Participation

- ART: All work exhibited must be original, designed and produced by or under the direct supervision of the exhibiting artist.
- SAMPLES: Artists must provide samples of the type of work to be sold either through mailed photographs or emailed high-res. jpgs.
- STAFFING: Artists or their representatives must be present to sell their work for the full time the gallery is open, except in cases of serious personal emergency or by special arrangement with SHAC
- RESPONSIBILITY: Neither The Dealership nor the Shaker Arts Council is responsible for any personal injury during this event.
- FEES: Due upon application review and acceptance artists will be required to pay the appropriate fee.
- SPACE: Artist space to be determined. Artists will work directly with SHAC to determine best set up for artist and show. Each potential applicant must apply individually. No booth sharing.
- DAMAGE: SHAC will not be responsible for any damage or theft of personal belongings or merchandise. Artists are responsible for their areas. SHAC advises that artist carry their own insurance. Any accidents caused by the artist's set-up or goods will be the artist's responsibility.
- REFUNDS: SHAC cannot give refunds for artist's fees due to circumstances beyond its control.

- STATE SALES TAX: All artists are responsible for abiding by all tax laws and collecting applicable taxes on each sale. For more Information, contact the Ohio Department of Revenue or view taxation requirement son the State of Ohio website.
